### RELEASE and HOLD HARMLESS AGREEMENT

This is a legal document, which includes a release of liability. Read it carefully before signing.

I have freely chosen to participate in the Water is Life 2020 Conference and I/we hereby assume the risks associated with this trip (hereafter referred to as the Trip).

I/we understand that all major participants' school rules and those communicated in the Codes of Conduct located in Information Pack 4 will be in effect during the Water is Life 2020 Conference (hereafter referred to as the Conference) and on the Trip.

**MEDICAL RELEASE:** I understand that the Conference and Trip may subject me/my child to physical exertion (walking) and possible exposure to germs, contagious diseases and different foods. I/we hereby consent to treatment, evacuation, anesthesia, and/or operations which might become necessary in the event of a medical emergency while I/my child is a participant during the Conference and on the Trip. Every effort will be made to contact a parent/guardian in an emergency. I/we understand that health and accident insurance coverage during the Conference and on this Trip is the responsibility of the participant or their parent/guardian and I/we have suitable coverage.

**RELEASE and HOLD HARMLESS:** I/we do hereby release and forever discharge Saint Stephen's Episcopal School (hereinafter referred to as the School) and their agents, representatives, trustees, employees, officers and service providers (hereinafter collectively called Indemnitees) from any and all liability, actions, causes of action, claims and demands of any nature whatsoever, which I/we may ever have as a result of our participation in this Conference and Trip. I/we agree to indemnify and hold the Indemnitees harmless from any and all damages, loss or liability occurring by reason of any injury to any person or property caused by an act, omission, neglect or wrongdoing of the Indemnitees, myself/my child, which may arise out of our participation in this Conference and Trip. I/we hereby assume all risk of injury associated with this Conference and Trip.

**TRANSPORTATION:** I/we understand that I/we are fully responsible for my/my child's transportation home and the costs thereof if he/she is dismissed for behavior, disciplinary or medical reasons. I/we understand that such dismissal is at the full discretion of the chaperone and the School.
